Dear Mr. Drumbore:

As a result of the COVID-19 global pandemic, the sixty-day period in which to hold the first hearing concerning your conditional use application has been extended. Governor Wolf signed Act 15 of 2020 which provides for a tolling and suspension of the time periods for holding hearings on pending conditional use applications under the Pennsylvania Municipalities Planning Code. Specifically, Act 15 of 2020 suspends the applicable time periods as of March 6, 2020 and the time will begin to run again on May 20, 2020. Your application concerning the above listed matter was filed on March 16, 2020 with Springfield Township. As a result, the Board of Supervisors will have 60 days from May 20, 2020 to hold its first hearing.

Please allow this letter to serve as notice to you that Act 15 of 2020 provides you with the right to request that your application be heard during the disaster emergency that has been declared by Governor Wolf. To do so, you must submit a request prior to the end of business on May 20, 2020. The Township Board of Supervisors has the discretion to determine whether it can provide adequate notice to all interested parties and allow for the requisite public participation. If the Township elects to conduct the hearing, you waive any challenge to the proceedings under the Open Meetings Law and any other provision of law that governs the notice, conduct or participation in a meeting

or proceeding. Please advise in writing on or before May 20, 2020 if you wish to request your application be heard by virtual hearing.

Should you not request a virtual hearing, the Board of Supervisors remains committed to scheduling your hearing as promptly and safely as possible within the Municipalities Planning Code and Act 15 of 2020 timelines. However, due to the uncertainties concerning when a true public hearing will be able to occur, the Township is asking you to consider executing the enclosed Waiver of the time requirements contained in the Municipalities Planning Code. This Waiver will provide the Township until July 31, 2020 to hold its first hearing. The Township appreciates your anticipated cooperation in this regard.
