MINUTES NOVEMBER 22, 2022

APPROVAL OF MINUTES

Motion by Mr. Nilsen, seconded by Mr. Ryker and unanimously carried approving the October 11, 2022, October 25, 2022, minutes, as presented.

BUSINESS ITEMS

ZHB Applications – **Conshy Cooper Farms & Looking Up Enterprises** – Solicitor MacNair advised he would attend for the BOS but needed to know what position the BOS would like him to take at the Zoning Hearing Board. It was decided Solicitor MacNair would attend and make sure the record is complete. They will support the ZHB decision. Mr. Michael Clime, 2212 High Meadow Rd, stated he has objections to what Conshy Cooper wants in their ZHB application. Mr. Pete Jones (Zoom), 1876 Salem Road, asked about the property being Act 319. Solicitor MacNair stated that is regarding tax treatment.

Solicitor MacNair asked about their recommendations for the Looking Up Enterprises application. They are asking for a flag lot variance and BOS stated they agree with the flag lot. Solicitor MacNair advised he would write a letter of support regarding the variance request to the ZHB.

DVHT Resolution/Agreement – The Township is switching to DVHT for health care effective 1/1/23 with a three-year agreement. It will save the township money in the long term.

Motion by Mr. Nilsen, seconded by Mr. Kade and unanimously carried to adopt **Resolution 2022-21** authorizing Springfield Township to enter into an intergovernmental cooperation agreement and participate in the Delaware Valley Health Trust and further authorize the Chair and Manager to sign all paperwork necessary.

Board Appointments – ZHB & P&LPB – Mr. Jay Fuggiti volunteered to fill the opening on ZHB and join the Parks and Land Preservation Board. He will resign from the Planning Commission. Motion by Mr. Kade, seconded by Mr. Matzura and unanimously carried appointing Mr. Fuggiti to the Zoning Hearing Board for a term ending 12/31/25 and Parks and Land Preservation Board for a term ending 12/31/2024.

2023 Budget discussion/advertisement authorization – There was a 2023 Budget recap noting two previous Board of Supervisors work sessions. Motion by Mr. Nilsen, seconded by Mr. Matzura and unanimously carried authorizing advertisement of the 2023 proposed budget for Springfield Township.
